Direct Banking W1, NL, BE

Direct Banking is available worldwide, Ponto connects only to EU banks, Cobase to EU banks and non-EU banks.

To use Direct Banking, two components are required; the Direct Banking extension developed by idyn and either a Ponto account or a Cobase account. Direct Banking is licensed per Business Central database.

Overview of banking platforms available

Direct Banking integrates your preferred banking platform into Business Central. For BC accounts with only European bank accounts Ponto is the optimal option. For BC accounts with bank accounts outside of Europe (non-IBAN and/or international payments (non SEPA) Cobase is preferred).

Ponto

Connect your bank accounts via the Ponto platform in accordance with PSD2 and Open Banking legislation. Daily statements are directly imported into your Business Central. Payments will be exported directly to the Ponto platform for approval. No more file exchanges needed.

Cobase

Connect to the Cobase platform with over 15,000 integrated banks worldwide. Perform your banking from Business Central and authorize payments across all your banks with a secure app or token, no need to enter or use banking credentials to execute payments.

Object Manager Advanced (for NAV)

Development version

Available for partners and end users.

For end users there are 2 price levels for the add-on, based on the presence of following modules:

The development add-on is licensed per PSBC ID (formerly Voice ID) through MS granule 11102055 OMA Developer Edition.

Customer Deployment version

Separate module which can be used to deploy objects to customers. User count is as reported by Microsoft PartnerSource in the ISV module install base reports*. This module is available for end user companies:

- Without development modules 7200 and/or 7300 in their NAV/BC license.
- Related NAV/BC partner or parent company is licensed to a development version of OMA.

*A NAV license upgrade (user increase over 20 or adding the SD module (7300)) requires a mandatory OMA upgrade.

The deployment add-on is licensed per PSBC ID (formerly voice ID) and is licensed through MS granule 11102060 OMA Customer Edition.

Invoices for subscription fees are sent by idyn before the start of the next period and have a 30 days NET payment term.

An invoice for subscription fee is not paid in full in due time by partner, then idyn retains the right to end the subscription plan. To reactive a terminated subscription plan idyn raises an invoice containing fee(s) for the elapsed period(s) where elapsed periods are calculated starting from the last period for which payment was received up until the current period. An administration fee equal to one month subscription fee.

Migrating NAV license to BC subscription

Customers who are currently using NAV add-ons and wish to upgrade their current solution(s) to the Business Central version(s) can do so:

- Subscription customers: the NAV based subscription will terminate upon expiry of the current period and will be replaced to an AL based subscription when a license key has been issued.
- Customers with perpetual licenses and on valid maintenance plans: upon idyn issuing a license key for the BC app, the customer's maintenance plan continues for 2 years, after which the BC-based subscription will automatically start and be invoiced at the current pricing level that applies when transitioning to the subscription price (i.e., the prevailing price after the 2 years).

EULA and other conditions

End User License Agreement

The end User License Agreement (EULA) applies to all idyn software licenses. See: www.idyn.nl/end-user-license-agreement/
Currently the only accepted payment method is by bank transfer.
